Evaluation of the applicant's scholarly/artistic qualifications

The applicant is the author of more than 56 papers listed by Web of Science and his H-index is above 17. The applicant authored nine book chapters and gave 22 invited lectures. His papers were cited more than 1400-times.

Conclusion: The applicant's scholarly/artistic capabilities **meet** the requirements expected of applicants participating in a professor appointment appointment procedure in the field of Genomics and Proteomics.

Evaluation of the applicant's pedagogical experience

Teaching activities of the applicant date back to 2005. Dr Honys is teaching three courses at the Charles University (Faculty of Science), being a guarantor of two courses (World of RNA and proteins, Plant growth and development). The applicant supervised 11 and 8 bachelor's and master's theses, respectively; he surpervised four PhD theses and currently is supervising four PhD students at Charles University. He is an internal or external member of doctoral boards at three universities (Charles University, Masaryk University, Czech University of Life Sciences).

The applicant showed a long-term and focused dedication to the topic of pollen biology. He is one of the leading figures of pollen research in the worldwide context. Dr Honys is the author of more than 56 papers listed by Web of Science and his H-index is above 17. He is internationally collaborating with a number of research groups. He and his research groups were participating in several collaborative projects. Dr. Honys is certainly a respected and internationally recognized figure in the field of pollen biology.
